The undersigned, hereinafter called "Member", hereby applies for "security light", and agrees to purchase electric energy for same in accordance with the following conditions:

1. This agreement is NOT TRANSFERABLE and is not intended for commercial lighting purposes such as roadway, parking, or decorative lighting.
2. Where the security light service shall be installed upon an existing Cooperative owned structure, the Member shall be required to execute an agreement for one year. Early termination of this agreement will result in the Member being charged for the remaining term of the agreement at the applicable security light rates at that time.
3. If the Member requesting security light service desires the service for a period of time less than one year, the Member must pay all installation and removal costs, less salvage value of reusable materials. In this case, a written agreement will be executed between the Cooperative and the Member, detailing the cost of the security light service and the length of time that service will be installed.
4. Where the security light service requires the installation of pole structure (s) other than primary distribution poles, the Member shall pay a contribution in aid to construction charge of \$240.00 for each pole and execute an agreement for continuous service for a term of three (3) years. Early termination of this agreement will result in the Member being charged for the remaining term of the agreement at the applicable security light rates.
5. Where the security light service requires the installation of primary distribution lines, the Member shall pay the costs incurred for construction.
6. The type of equipment to be used and the method of installation shall be in accordance with Cooperative standards. The Cooperative's standard fixture is a 55 watt LED outdoor security light; requests for street or highway lights of greater wattage will be subject to excess facilities charges.
7. The complete installation, including pole or poles, if the Cooperative determines it necessary, is to be furnished, maintained and operated at Cooperative expense and will remain the property of the Cooperative.
8. Purchase of electric energy for security light service shall be in accordance with the rate schedule filed with the State Corporation Commission for Street, Highway, and Outdoor Lighting Service and is not metered. All kilowatt-hours used are subject to adjustments for changes in the cost of wholesale power and fuel under Schedule K of the Cooperative's Terms and Conditions.
9. The Member shall report to the Cooperative, as promptly as possible, any and all lights that are out or not burning properly. The Cooperative will endeavor to replace or repair such lights as its maintenance schedule allows.
10. Bills will be rendered monthly by billing cycle.
