MECKLENBURG ELECTRIC COOPERATIVE

SCHEDULE "SGS-U-NC" SMALL GENERAL SERVICE

AVAILABILITY

Service under this schedule is available to consumers for electric service in all territory served by the Cooperative in the State of North Carolina, where the consumer takes service at one delivery point through one kilowatt-hour meter.

APPLICABILITY

This schedule is applicable to consumers whose annual kW demand averages less than 50 kW per month, or whose highest monthly kW demand does not exceed 100 kW, subject to the established Terms and Conditions of the Cooperative.

CHARACTER OF SERVICE

Standard service under this schedule shall be 60-Hertz alternating current, single-phase, or multiphase where available, at Cooperative's standard secondary voltages. With the Cooperative's prior approval, service may be available at the Cooperative's standard primary distribution voltage.

MONTHLY RATE

I. Distribution Service:

Consumer Delivery Charges:

Single-Phase: \$ 27.00 per month Multi-Phase: \$ 59.25 per month

Demand Delivery Charges:

All kW over 30 kW delivered @ \$7.95 per kW

Energy Delivery Charges:

First 5,000 kWh delivered @ \$0.03307 per kWh
Over 5,000 kWh delivered @ \$0.00837 per kWh

II. Electricity Supply Service:

All kilowatt-hours used are subject to adjustment for changes in cost of wholesale purchased power and fuel under Schedule K of the Cooperative's Terms and Conditions.

MINIMUM MONTHLY CHARGE

The minimum monthly charge shall be the greater of the following:

- 1. The Consumer Delivery Charge shown above, or
- 2. The Contract Minimum as specified in a contract for electric service.

MINIMUM ANNUAL CHARGE FOR SEASONAL SERVICE

Consumers requiring service only during certain seasons not exceeding nine months per year may be subject to a minimum annual charge, in which case, there shall be no minimum monthly charge. The minimum annual charge shall be equal to twelve times the minimum monthly charge determined in accordance with the foregoing paragraph.

DETERMINATION OF BILLING DEMAND

When a consumer's monthly kilowatt-hour consumption exceeds 5,000 kWh, the Cooperative will install a demand meter suitable for measuring maximum demand unless a load count indicates the consumer's load is less than 30 kW. The Billing Demand for the current month shall be the maximum thirty-minute integrated demand established by the consumer during the month for which the bill is rendered.

SERVICE AT PRIMARY VOLTAGE

If the consumer takes service at Cooperative's standard primary distribution voltage and the consumer owns and operates its distribution system, a discount of two and one-half percent of the billed kWh energy and KW demand charges shall apply.

CONDITIONS OF SERVICE

In those cases where extraordinary investment is required to provide the service, it will be rendered only after the following conditions are met:

- 1. The consumer will give satisfactory assurance by means of a written agreement as to the character, amount, and duration of the business offered.
- 2. The consumer complies with the Cooperative's Terms and Conditions.

BILLING

Bills will be rendered by the Cooperative on a monthly basis, by billing cycle.

TERMS OF CONTRACT

Standard service shall be for an initial term of not less than one year, and shall continue in effect from year to year until terminated.

If a consumer discontinues service and requests a reconnection within less than one year, a payment equal to the minimum monthly charge for each month the service was disconnected must be made before service will be reconnected.
